EXPLORATION ACTIVITIES UPDATE FOR JUNE 2019

The board of directors ("**Board**") of Wilton Resources Corporation Limited (the "**Company**", and together with its subsidiaries, the "**Group**") wishes to inform shareholders of the Company that PT Renuka Coalindo Tbk ("**Renuka**"), the Company's subsidiary listed on the Indonesia Stock Exchange ("**IDX**"), had on 15 July 2019, released an announcement on the IDX entitled "Laporan Aktivitas Eksplorasi Bulan Juni 2019" ("**IDX Announcement**").

Mining Exploration Reports for June 2019

In respects to the IDX Regulation No. I-E regarding the Requirement to Submit Information, we hereby submit the Exploration Activities Reports for June 2019 of PT Renuka Coalindo Tbk.

Previous Exploration

Exploration activities of PT. Renuka Coalindo Tbk and its subsidiaries operating in Ciemas, Mekarjaya and Cihaur Villages, Ciemas District, Simpenan District, Sukabumi Regency. At present, there are 6 prospects, namely Cikadu (CKD), Sekolah (SEK), Cibat (CBT), Pasir Manggu (PSM), Cibak (CBK) and Cipancar (CPR), which have been explored and reported in the Independent Qualified Person Report in September 2018.

Exploration in June 2019

There is no exploration activity carried out during June 2019. The operational activity is focused on production where the construction of a gold processing plant with a capacity of 500 ton per day has reached its final stages.
