EXPLORATION ACTIVITIES UPDATE FOR DECEMBER 2019

Previous Exploration

Exploration activities of PT. Wilton Makmur Indonesia Tbk and its subsidiaries operating in Ciemas, Mekarjaya and Cihaur Villages, Ciemas District, Simpenan District, Sukabumi Regency. At present, there are 6 prospects, namely Cikadu (CKD), Sekolah (SEK), Cibatuan (CBT), Pasir Manggu (PSM), Cibak (CBK) and Cipancar (CPR), which have been explored and reported in the Independent Qualified Person Report (IQPR) in September 2018.

Exploration in December 2019

There is no exploration activity carried out during December 2019. The operational activity is focused on a production where the construction of a gold processing plant with a capacity of 500 ton per day has reached its final stages.
