CHANGE OF FINANCIAL YEAR END FROM 30 JUNE TO 31 DECEMBER

The board of directors (“**Board**”) of Wilton Resources Corporation Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) wishes to announce the change of the Company’s financial year end from 30 June to 31 December (the “**Change of FYE**”). Following the Change of FYE, the current financial year of the Company will cover a period of 18 months from 1 July 2019 to 31 December 2020 (“**FY2020**”). Thereafter, the financial year of the Company will commence on 1 January and end on 31 December of each year.

The Change of FYE is to align the financial year end of the Company with that of PT Wilton Makmur Indonesia Tbk (“**PT WMI**”), the Company’s subsidiary listed in Indonesia. PT WMI had, on 11 October 2019, effected a change of its financial year end to 31 December. The Board is of the view that the Change of FYE will allow for better management of the Group’s internal processes in coordinating its financial reporting requirements with external parties which will result in better administrative and operational efficiencies.

In accordance with Rules 705(1) and 705(3)(b)(ii) of the Singapore Exchange Securities Trading Limited Listing Manual Section B: Rules of Catalist (“**Catalist Rules**”), the Company will be releasing the announcement of its financial results in the following manner within the time frames stipulated below:-
