Mr Teo refers to the media release by the Commercial Affairs Department, the Accounting and Corporate Regulatory Authority and the Money Authority of Singapore (the "**Authorities**") on 2 June 2020, on the Authorities' joint investigation on potential lapses in certain disclosures by Hyflux Ltd ("**Hyflux**") on its Tuaspring Intergrated Water and Power Project and possible accounting irregularities.
