EXPLORATION ACTIVITIES UPDATE FOR THE THIRD QUARTER ENDED 30 SEPTEMBER 2023

The board of directors ("**Board**") of Wilton Resources Corporation Limited (the "**Company**", and together with its subsidiaries, the "**Group**") wishes to inform shareholders of the Company that PT Wilton Makmur Indonesia Tbk ("**PT WMI**"), the Company's subsidiary listed on the Indonesia Stock Exchange ("**IDX**"), had on 10 October 2023, released an announcement on the IDX entitled "Laporan Aktivitas Eksplorasi Triwulan III 2023" ("**IDX Announcement**").

Mining Exploration Reports for 3Q2023

In respects to the IDX Regulation No. I-E regarding the Requirement to Submit Information, we hereby submit the Exploration Activities Report for 3Q2023 of PT Wilton Makmur Indonesia Tbk.

Previous Exploration

PT. Wilton Makmur Indonesia Tbk and its subsidiaries are operating in Ciemas, Mekarjaya and Cihaur Villages, Ciemas District, Simpenan District, Sukabumi Regency.

At present, there are 6 prospects, namely Cikadu ("CKD"), Sekolah ("SEK"), Cibatu ("CBT"), Pasir Manggu ("PSM"), Cibak ("CBK") and Cipancar ("CPR"), which have been explored and reported in the Independent Qualified Person Report ("IQPR") in September 2018. The IQPR is independently prepared by SRK Consulting China Ltd.

Exploration in 3Q2023

There is no exploration activity carried out during 3Q2023. The operational activity is focused on the Commercial Production of its Flotation and Carbon-in-Leach Processing Facility.
